Corperate Overview

China Water Affairs Group Limited (hereinafter referred to as "China Water Affairs" or the "Group", Stock code: 855.HK) is a leading market oriented and cross region water supply operator in China and the only Hong Kong listed water company focusing on tap water. Headquartered in Hong Kong with two operation management centers in Beijing and Shenzhen. Included in the first batch of Shenzhen-Hong Kong Stock Connect by HKEX in 2016. Included in the FTSE Environmental Opportunities Asia Pacific Index since 2009.

By investing, building and operating water affairs projects in China, the Group provides raw water, tap and direct drink water supply, sewage treatment, drainage business, water environment comprehensive management and other municipal infrastructure and hydraulic project related services. Total capacity: over 20 million m³/per day; Business covering over 100 cities in 20 provinces and 3 municipal cities of Chin; Covering over 30 million population; Connected meters: 7.46 million. The total length of the water supply piping network surpasses 158,000 kilometer.

The company is a pioneer in adopting the PPP model in the domestic water supply industry. It mainly adopts TOO (transfer-own-operate) business model for tap water operations and jointly holds ownership of projects with the government. As a public utility business that is stable, continues to grow, and has economies of scale, it is relatively unaffected by economic cycles.

China Water Affairs adheres to the core corporate values of "Focusing on water and passing on goodness". Cooperating with the favorable reform policies of the water industry, our business continues to focus on the twin core business of tap water and pipeline direct drinking water supply, further carry out the integration of urban and rural water supply, integration of water supply and drainage, and speed up the disposal of non-core business.



Continuously Rising Operating Cash Flow




The water supply business registered stable growth in revenue (in million HKD)

Rising Dividends (In HKD Cent)


